

NovaLash Student Agreement

1. I understand that payment for the seminar must be completed at least 10 business days prior to the seminar date. Payments are non-refundable once the Seminar Skills Manual has been sent to me.
2. If I am unable to attend my scheduled training, I will contact my trainer to reschedule prior to the seminar.
3. I am eligible to attend a follow-up hands-on seminar if needed. The follow-up seminar is to be taken with the instructor who gave the initial training and must be attended within 6 months of the original seminar.
4. I will bring my own supplies to the training seminar or I will bring my complete Business in a Box kit. I understand that I will not be able to participate in the seminar unless I bring these items to class.
5. I understand that ALL students are required to attend the theory section of the class and participate in the practical section of the class in order to be considered for certification.
6. I understand that I must successfully and correctly apply at least 10 extensions on a live model to be considered for certification.
7. I understand that I must pass (70%) the written exam AND hands-on skills evaluation in order to be considered for certification.
8. I understand that I am required to bring my own model to the seminar.
9. I understand that NovaLash corporate will issue a NovaLash Certified Lash Extensionist Certificate upon successful completion of at least 5 online case studies.
10. I understand that trainer observation time of students will vary and there will be supervised and independent work time intermittently throughout the hands-on training.
11. I understand that NovaLash, Inc. provides trainers with a prefabricated curriculum but makes no guarantees to the extent the material will be covered.
12. I understand that NovaLash, Inc. will not mediate disputes between students and trainers. If I would like to submit a formal complaint I may do so by filling out the evaluation form handed out at the end of the seminar and mail it to NovaLash, Inc. within 10 days of my seminar.
13. I understand that qualification for certification is up to the discretion of the trainer and I am not guaranteed to pass the NovaLash Classic Training Seminar or receive a NovaLash Certified Lash Extensionist Certificate.
14. I understand that the NovaLash Classic Training Seminar is not suitable for persons with neurological disorders that cause uncontrollable shaking, muscle spasms, or trembling that would impair them from safely applying lash extensions.

I understand that I must send in 3 different models before and after photos to NovaLash, Inc. before receiving marketing support, advertising materials (beyond what is included in the Business in a Box) and/or access to add my professional listing on novalash.com. I understand that NovaLash reserves the right to deny any NovaLash Certified Lash Artist from being listed on the site.
16. I understand if NovaLash Inc. shows purchase inactivity on my account for more than 2 years then I will be required to pay for and attend a NovaLash refresher course in order to be eligible to purchase the Platinum Bond.
17. I understand that I must purchase at least 3 bottles of Platinum Bond Adhesive and at least 6 pots/trays of lashes per year in order to be listed as a professional on novalash.com or to use NovaLash branded marketing materials.
18. As a NovaLash Certified Lash Artist I must demonstrate an understanding of the technique and ability to apply lash extensions safely and properly before charging clients for the service.
19. I understand that practice is one of the main ingredients for my success as a professional lash artist and that it is my responsibility to find models to practice on immediately following the training seminar.
20. I will limit my caffeine intake before and during the training seminar, and understand that lunch may or may not be provided by the trainer. ____
21. I will not create, use, or alter any copyrighted NovaLash images or materials for promotional or marketing purposes without approval from NovaLash, Inc.

I understand that NovaLash Inc. is not a higher education institution such as a college, university, vocational school or other post-secondary educational institution eligible to participate in a student aid program run by the U.S. Department of Education and NovaLash is not eligible to issue an IRS form 1098-T to students.
